The the CSR Cordinator and VP (Human Resoruces) shall be involved to ensure that the expenditure qualifies as per the provisions of the Companies Act and the CSR Policy of the Company.
- (2) The Construction and setting up of new school or hospital would alternatively be taken up by the Company as turn-key, multi-year, ongoing project and a detailed feasibility study, need assessment should be carried out to finalize the same.
- (3) The CSR spending as approved may vary upto 10%, subject to ceiling of maximum amount to be spent as per the CSR budget for the year.
